



Chewton Glen Hotel & Spa Prize Draw Terms & Conditions

1. The prize draw is operated solely by FOCUS Oxford Risk Management Ltd, referred to hereafter as FOCUS.
2. The prize on offer is a voucher for a 2-night dinner bed and breakfast stay at Chewton Glen Hotel & Spa and is subject to the terms and conditions of the voucher. The voucher is valid for two nights for two guests sharing. Subject to availability and excluding Bank Holidays, Christmas and New Year.
3. The prize draw (the "prize draw") is open to people aged 18 and over who provide the date of their mortgage rate review or intended home/property purchase date.
